6.1 Year End Position

Williams confirmed that following all the year-end entries, the year-end surplus to be transferred to the Library Tax-Rate Stabilisation Reserve is \$86,135.

6.3 COVID-19 Update

6.5 Firewall Contract Award Notification

Following a review of firewall services at MPL, a request for quotes was tendered in Q4 2021. The successful vendor is Lanworks. Staff will monitor and review the service throughout 2022.

7.1 COVID-19 Public Access Policy

As a result of the relaxation of all Public Health guidelines Montesano brought forward the repeal of this policy. Going forward, staff will continue to monitor all the Public Health recommendations and government requirements in relation to COVID-19.

7.2 Non-Medical Facemask Policy

7.3 MPL Uniform Recommendation

Staff are recommending the introduction of uniform pieces that include polo shirts, button down shirts and sweaters driven by MPL's corporate brand colours with the bee embroidered on the chest of each item. The initial investment is approximately \$20,000 and can be absorbed in the current year's operating budget. The ongoing operational budget line for replacement pieces will be a lesser amount.

7.10 Main Library Expansion Budget Increase

Williams presented the report on the Main Library Expansion Budget Increase for the Board's approval. Further to the initial discussions and approval at the Town Council meeting on 6th December 2021, finer detail of the expansion has been prepared and a more detailed budget is ready to be presented to Council to fund the expansion accordingly. Staff are seeking approval from the Board to support the increased budget request of Town Council.
