### 5.1 Withdrawn Book Sale Update

Williams updated the Board that the Book Sale that took place at all branches from September 21<sup>st</sup> to 27<sup>th</sup> generated over \$4,000. It is hoped that left over items may be used to create a type of public art that will be located at Beaty Branch and a grant application will be submitted in order to fund this project.

### 6. Decision Items

### 6.1 Draft 2021 Operating Budget Recommendation

Williams reported that MPL is seeking a 5.32% increase to the 2021 Operating Budget which includes a transfer of \$150,000 from the Library Tax Rate Stabilisation Fund (LTRSF) to offset the operating costs of Sherwood in years one and two. This represents a reduction of the transferred amount of over \$200,000 from 2020 and aligns with the purpose of the LTRSF. MPL will continue to work with Town Finance to refine the budget as needed, bringing forward any changes to the Board at the next meeting.

### 7. Reports and Updates

### 7.1 Chief Librarian's Monthly Report

Williams highlighted some key activities from September 2020:

- The Summer Reading Club stats show that even though the event was held virtually, there were over 2,500 participants
- The MPL Online Storytimes shared on YouTube had almost 600 views in September
- The Halton Youth Disability Advisory Council re-started their meetings in September with a focus on mental health, suicide awareness and continued learning opportunities
- The first Laurier Milton Lecture Series event was held virtually in September with 38 participants, and has since been viewed 89 more times on the MPL YouTube channel
- Culture Days were kicked off at MPL with a virtual storytime local author Sara Reda read her book "Bunny and Bear: First Day of School". Over 1400 people watched the video on MPL's Facebook page
- The Arabic Storytime, in partnership with MCRC, resumed on MPL's YouTube channel
- The National Centre for Truth and Reconciliation at the University of Manitoba gave permission for MPL to stream the "Every Child Matters: Reconciliation through Education" event as the first of MPL's virtual volunteering opportunities for high school students
- The Halton Climate Collective #HCCReads 2020 author, Sheila Watt-Cloutier, was confirmed for 19<sup>th</sup> November, 2020. Watt-Cloutier will discuss climate change as a social justice issue, particularly as it pertains to her decades-long work in the Canadian high arctic
- Physical circulation of materials is down 44% over the previous year, due to the Covid restrictions, however our e-usage continues to grow

- Brainfuse saw a 540% increase in September (589 total uses) over August (92 total uses).
  In addition to higher usage, 100% of students reported that they would recommend
  Brainfuse to a friend, and 100% are glad MPL offers this service
- Patrons viewed 85,000 pages on the MPL mobile app in September
- E-learning usage increased 200% in September over the same period in 2019
